





NEW SCHOLARSHIP MONEY POLICIES

For 2025-2026, the PJBT will continue to manage all Scholarship Funds internally until further notice. When graduation from High School comes, you can contact the PJBT to obtain your scholarship.

Congratulations! You have won scholarship money at today's PJBT event. Below are the new PJBT Scholarship Policies and Claiming Rules. Please note these for your records.

The PJBT does not send out statements. Once you earned your first scholarship, you will receive an email with your login ID and password to login to your MAPS Account. It is bowlers responsibility to check their own account and make sure it is accurate.

Scholarship Rules

- 1. Scholarship Money can be claimed and used by the bowler who wins as soon as they graduate from high school. Only the bowler who wins it can use the scholarship money. Transferring of funds from one bowler to another is NOT PERMITTED unless approved by tournament management.
- 2. Bowlers have up to 6 years after graduating high school to use their scholarship funds. If a bowler obtains scholarship in an event while in college...they have 6 years from the last date of winning scholarship to use their funds. Funds not claimed will be returned to the PJBT to redistribute at future events.
- 3. Scholarships are Permitted to Be Used ONLY for the Following:
 - Tuition fees, textbooks, meal & housing plans
 - Must be a university, college, business or technical school, trade or vocational school
 - Travel Expenses for Junior Gold National Championships (only hotel, airfare, rental car)
 - Entry into The PJBT Masters, BEST, and DV8 Scholarship Shootout at Junior Gold (These events are the ONLY 3 Tournaments that Scholarships Can be used for) (All other events are not permitted)
- 4. Bowlers **CANNOT** use scholarships for anything but the reasons listed above. PJBT will not grant scholarship funds for bowling equipment / dorm supplies/ laptops or anything else not listed above. PJBT has final say on status of approval. PJBT's decision is final and undisputable.
- 5. Checks, after approval by PJBT, must be made out to the college for Tuition. Checks will be sent to the school directly or to a bowler's parents for reimbursement. Checks will not be issued **EVER** to the bowler themselves. Checks will NOT be reissued for lost or stolen checks.
 - (Please note there may be tax implications when using these funds **DO NOT CONTACT PJBT** with tax related questions....please direct them to your local tax person)
 - 6. When claiming your scholarship funds, the PJBT MUST BE PROVIDED A HARD COPY of the tuition bill ON LETTERHEAD with Address of School & Students ID. <u>Bills MUST BE SUBMITTED THRU MAPS</u>. We do not accept emails or text messages of bills. Without provided documentation for filing and audit purposes, no scholarship money will be released.
